^{*}Planning Time Index, PTI, is a measure of reliability and the ratio of the 95th percentile travel time to the free–flow travel time. For example, travelers making this trip are on time 95 percent of trips (e.g., late for work on one day per month). A PTI of 1.60 indicates a 20-minute free–flow trip takes more than 32 minutes (20×1.60) one day per month.
